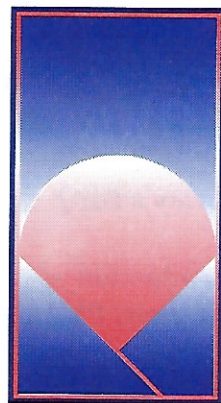

NIGHT OUT

Utahns stand up against crime

Thousands have fun at gatherings while sending message to criminals.

Thousands of Utahns joined others across the nation Tuesday in celebrating a night against crime.

About 400 individual gatherings, ranging from block parties to city events, dotted the Salt Lake County area alone, said Tab Uno, community organizer for Utah's Neighborhood Action Coalition.

And Provo's first attempt at participation in the national Night Out Against Crime was also met with enthusiasm.

"The whole idea is for people to have fun while sending a serious message against crime," Uno said.

As part of the celebration, Salt Lake Police Chief Ruben Ortega participated in a parade through the Glendale neighborhood. The route ended at the Sorenson Mul-

Neighbors find strength in numbers

They discover they really can make a difference if they unite and speak out.

Two Salt Lake women concerned about crime in their communities have discovered that crime fighting involves more than calling the police.

Within a week after moving to her new Rose Park home, Angela Morgan became suspicious that some illegal drug activity was taking place at a house across her street. She noticed limousines stopping there on a regular basis.

But once she began to find hypodermic needles in her gutter, she knew she had to do something about it.

"I wanted these drug dealers out of my neighborhood," she said.

That's when she began nailing signs outside her house.

Among her most indignant messages, one of the signs read, "Why say nope to dope when a drug dealer lives across the street at . . ." and here she cited the exact address.

Another sign was a cry for help to her neighbors: "The Lord shall stand beside me. What about my neighbor?"

The signs also included phone

numbers to police, narcotic agencies and even the mayor. It was a gutsy approach. But despite her worst fears, her community responded.

"People would honk when they drove by and gave me a thumbs up," Morgan said. "By putting those signs up, I only voiced what everybody else was afraid to voice."

"It got the point across," agreed Michelle Richar, who soon began to work with neighbor John McConkie to form a neighborhood watch.
